TERMS AND CONDITIONS

1. Our website Use of this website provided by GOSPIDES ("Us") by your business, officers and employees, ("You") and any service contained within constitutes acceptance of these Terms & Conditions.

2. Customer Use

2.1 You should always check the contact information you provide is correct before creating a customer account or proceeding subscription offered by Us.

2.2 Our website is only intended for use by adults, as defined as those aged 18 or over and who have sufficient capacity to enter into a binding agreement.

Account Integrity

3.1 As part of the registration process you will need to create an account, including a username & password. It is your responsibility to ensure that the information you provide is accurate and not misleading. You cannot create an account or username & password using the names and information of another person or using words that are the trademarks or the property of another party or vulgar, obscene or in any other way inappropriate.

3.2 You are responsible for maintaining your own username and password via our website. You should ensure that you store your username and password securely and that the details required to access your customer account are not provided to another party.

3.3 You are responsible for your customer account and any actions taken within it. If you are aware or suspect that your customer account username and password or other details have become known to a third party, you should inform us immediately.

License to use the website

4.1 You may:

- (b) print pages for personal use not for selling purpose

Subject to the other provisions of these terms and conditions.

4.2 You may only use our website for your own personal purposes and may not use the site for any other purposes.

4.3 Except as expressly permitted by these terms and conditions, you must not edit or otherwise modify any material on our website.

4.4 You cannot:

- (a) republish materials from our website
- (b) sell, rent or sub license material from our website
- (c) show any material from our website in public
- (d) exploit material from our website for commercial purpose

4.5 Notwithstanding Section 3.5, you may redistribute (our social media platform) in print and electronic form to any person.

4.6 We reserve the right to restrict access to areas of our website, or indeed our whole website, at our discretion; you must not circumvent or bypass, or attempt to circumvent or bypass, any access restriction measures on our website.

Acceptable use

5.1 You must not:

- (a) use our website in any way or take any action that causes, or may cause, damage to the website or impairment of the performance, availability or accessibility of the website;
- (b) use our website in any way that is unlawful, illegal, fraudulent or harmful, or in connection with any unlawful, illegal, fraudulent or harmful purpose or activity;

User login details

6.1 if you register for an account with our website you will be asked to choose a user ID and password.

6.2 Your user ID must not be liable to mislead and must comply with the content rules set by the company, you must not use your account or user ID for or in connection with the impersonation of any person.

6.3 You must keep your password confidential

6.4 You must notify us in writing immediately if you become aware of any disclosure of your password.

Cancellation and suspension of account

7.1 We may:

- (a) edit your account details;
- (b) temporarily suspend your account; and/or

At anytime in our sole discretion, providing that If we cancel your subscription (activated account), you will not be able to apply for refund. We will give you a written notice of any cancellation under this section 7.1

7.2 You may cancel your account by writing a letter to the company.

Subscription

8.1 Regular subscription to our social media site is free to public, to access premium affiliate subscription services, you must pay the applicable affiliate subscription fee (during the account registration procedure) or (after you have registered for an account with our website). We will send you an acknowledgement once you register as a premium subscriber or affiliate. The contract between us shall come into force upon accepting this agreement.

10.2 A charge of 2% from total amount of payout will be deducted to the payout of the payee for bank transfer.
